The Georgia National Fairgrounds & Agricenter has partnered with the Georgia Department of Agriculture to offer the Georgia Grown Pavilion in the Georgia Grown Building at the 2016 Georgia National Fair.

The Georgia Grown Pavilion will operate as a consignment store for agriculture products processed or manufactured in Georgia. Participants will be responsible for the delivery of their product, setup prior to the fair, and removal of their product after the fair. Products sold in the store must have a scannable UPC code. The Georgia National Fair will staff the store, restock the product throughout the event, and take responsibility for handling of sales tax. To cover the cost of operating the store, the Georgia National Fair will retain a 18% commission on the gross sales of all products. To promote the Pavilion and drive traffic, a coupon with a “10% off of a single item purchase, (limit one per person)” will added to the schedule of events. Participants will be required to honor this coupon. Sampling may be available at the store at selected times on a first-come-first-serve basis. Completed application **must be received by August 15<sup>th</sup>**.
